License Tax for Partial Year

“Each License issued prior to the first day of January of any year shall be charged for the full rate and each license issued on or after the first day of January shall be charged for one half of the full rate”

Should check be given in payment of any of the above license fees, and returned for lack of funds, license shall be revoked as provided by law. Penalty of \$50.00 per month for continuing to do business without license (Chapter 2 Article 751.99).
