

**Fayetteville Town Council met in Regular Session on November 7, 2019 at 6:00 p.m. at Town Hall.**

Consider Home Rule Option. Town Attorney Carl Harris will get the information to us by the next Council Meeting on November 14, 2019.

Consider adding K-9 Officer to the Police Department. Chief of Police David Kinzer said with all the drugs on Route 19 it would be a great help have a K-9 Officer. The money would come out of the Equipment fund and Contingency fund. The price of the dog would include training and personal equipment. Okey Skidmore made a motion to approve. Zenda Vance asked if it would be cheaper if 2 K-9 Officers were purchase. Chief Kinzer said they would get a better price if 2 were purchased at the same time. Sometimes it is hard to get a K-9 when needed from the Sheriff Department. Okey Skidmore amended this motion to purchase 2 K-9 Officers and Stanley Boyd seconded the motion. Brian Good, Gabe Pena, Zenda Vance, and Lori Tabit approved the motion. Motion carries 8-0.

The Committee will include Enforcement Agency, Mayor, Town Superintendent, Building Inspector, Council Member (Gabe Pena) and Person at Large. Second Reading will be at December Council meeting. **Okey Skidmore said Halloween went smooth. Glad to have Matt Diederick on board.**


**Stanley Boyd said volunteers for Wreaths Across America.**
