

**Fayetteville Town Council met in Regular Session on March 7, 2019, at 6:00 p.m., at Town Hall.**

**Present were Mayor Dennis Hanson, Recorder Zenda Vance, Council Members Sharon Cruikshank, Stanley Boyd, Lori Tabit, and Okey Skidmore. Also present were Town Superintendent Bill Lanham, Chief of Police David Kinzer, Town Attorney Carl Harris, and Treasurer Kathy Williams. Frank Hindson was not present.**

**Mayor Hanson opened the meeting with the Pledge of Allegiance.**


