

**Fayetteville Town Council met in Regular Session on October 1, 2020 at 6:00 p.m. at Town Hall.**

**Present were Mayor Sharon Cruikshank, Recorder Zenda Vance, Council Members Stanley Boyd, Lori Tabit, Brian Good, and Gabe Pena. Also present were Fire Chief John Vernon, Town Superintendent Matt Diederich, Chief of Police David Kinzer, Town Attorney Carl Harris, and Treasurer Kathy Williams. Okey Skidmore was not present.**

**Prayer was offered by Mayor Cruikshank.**

**Mayor Cruikshank called the meeting to order.**

**Pledge of Allegiance was led by Zenda Vance.**
