

Fayetteville Town Council met in Special Session on September 17, 2020 at 4:00 p.m. at Town Hall.

Present were Mayor Sharon Cruikshank, Recorder Zenda Vance, Council Members Okey Skidmore, Stanley Boyd, Lori Tabit, Brian Good, and Gabe Pena. Also present were Fire Chief John Vernon, Town Superintendent Matt Diederich, Police Chief David Kinzer, Town Attorney Carl Harris, and Treasurer Kathy Williams.

Prayer was offered by Mayor Sharon Cruikshank.

Mayor Cruikshank called the meeting to order.

Pledge of Allegiance was led by Zenda Vance.

NEW BUSINESS:

First reading to update Court Cost fees. Brian Good moved too approve and Lori Tabit seconded the motion. Okey Skidmore, Zenda Vance, Stanley Boyd, and Gabe Pena approved the motion. Motion carries 6-0.

Discuss and act on 4 wheeler/atv ordinance. The Town has an ordinance prohibiting riding 4wheeler/atv vehicles on streets. Mayor Cruikshank asked if Council wanted to leave the Ordinance as is or change it. Brian Good moved to leave ordinance as is and Gabe Pena seconded the motion. Lori Tabit, Zenda Vance, Stanley Boyd, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and review other ordinances. Mayor Cruikshank wanted to inform Council there are several ordinances that need to be changed and updated and will be put on the October agenda. These items for some reason went through the process, however they were never completed.

Discuss and act on joining the Work @ Health program. Town Superintendent Matt Diederich will get with Work @ Health to announce a Team Leader. Lori Tabit moved to approve and Stanley Boyd seconded the motion. Okey Skidmore, Zenda Vance, Gabe Pena, and Brian Good approved the motion. Motion carries 6-0.

Discuss and act on Halloween. Council discussed and Mayor Cruikshank tabled until October Council meeting.

Discuss and act on boiler maintenance at new Police Department. Normal maintenance would cost around \$3,000.00. Zenda Vance moved to approve and Lori Tabit seconded the motion. Okey Skidmore, Stanley Boyd, Gabe Pena, and Brian Good approved the motion. Motion carries 6-0.

Mayor Cruikshank asked for a motion to go into Executive Session to discuss a personnel issue. Zenda Vance moved to approve. Council went into Executive Session at 4:15 p.m. and reconvened at 4:40 p.m. with no decisions rendered.

Discuss and act on Police Pay increases. Zenda Vance moved to approve as presented to Council by Chief of Police David Kinzer and Stanley Boyd seconded the motion. Okey Skidmore, Lori Tabit, Gabe Pena, and Brian Good approved the motion. Motion carries 6-0.

Discuss and act on sale of the two school properties. Mayor Cruikshank asked for a motion to table until we receive surveys. Zenda Vance moved to approve and Gabe Pena seconded the motion. Okey Skidmore, Lori Tabit, Stanley Boyd, and Brian Good approved the motion. Motion carries 6-0.

Zenda Vance moved to adjourn and Gabe Pena seconded the motion.
