Present were Mayor Sharon Cruikshank, Recorder Zenda Vance, Council Members Brian Good, Gabe Pena, Stanley Boyd, Lori Tabit, and Okey Skidmore. Also present were Town Attorney Carl Harris, Chief of Police David Kinzer, and Treasurer Kathy Williams.

Discuss and act on updating the first aid kits and fire extinguishers for Town and Police Department. Okey Skidmore moved to approve and Stanley Boyd seconded the motion. Lori Tabit, Gabe Pena, Brian Good, and Zenda Vance approved the motion. Motion carries 6-0.

Discuss and act on approval of \$700 to install door poppers for K=9 vehicles. Gabe Pena moved to approve and Brian Good seconded the motion. Okey Skidmore, Stanley Boyd, Lori Tabit, and Zenda Vance approved the motion. Motion carries 6-0.

Discuss and act on approval of \$758 to purchase recorders and digital cameras for officers. This will keep the Officers from having to use the camera on their cell phones. Brian Good moved to approve and Gabe Pena seconded the motion. Okey Skidmore, Lori Tabit, Zenda Vance, and Stanley Boyd approved the motion. Motion carries 6-0.

Discuss and act on 1 cruiser for Police Department-possible new grant. The Police Department has submitted paperwork for a grant from the Walmart Foundation and is working with US Representative Carol Millers office for an additional grant. Mayor Cruikshank said this would need to be approved matching funds for the submitted grant. Okey Skidmore moved to approve and Brain Good seconded the motion. Lori Tabit, Zenda Vance, Stanley Boyd, and Gabe Pena approved the motion. Motion carries 6-0.

Discuss and act on how to handle COVID leave. Town Superintendent Matt Diederich said he thinks it would be good for the employees because some of them would not have the time to take off if they were exposed or if they would get Covid. Employees would have to have a Dr excuse or something from the Health Department showing they were exposed. The leave would be for a total of 10 days with a Dr excuse and would be through September 30, 2021. Brian Good moved to approve and Gabe Pena seconded the motion. Stanley Boyd approved the motion. Lori Tabit, Okey Skidmore, and Zenda Vance voted against the motion. Due to a tie Mayor Cruikshank voted in favor of the motion. Motion carries 4-3.

Discuss and act of Vacation Rental requirements. Mayor Cruikshank asked for a motion to resent the Fire Marshalls requirements. Zenda Vance moved to approve and Lori Tabit seconded the motion. Gabe Pena, Brian Good, Stanley Boyd, and Okey Skidmore approved the motion. Motion carries 6-0.

Mayor Cruikshank asked for a motion to adjourn the meeting. Stanley Boyd moved to adjourn.
