Discuss and act on street parking, taking up more than one spot. People are double parking due to size of vehicles and car haulers are parking on streets. Space is limited for parking. Mayor Cruikshank said there isn't anything in the code currently for double parking and Town Attorney Carl Harris can write the code. Code 307.03-19 prohibits car haulers and they are in violation when parking on Street.

Discuss and Acton Street Parking, camping. Some larger vehicles are parking and sleeping on Streets. People are parking in spaces where signs say no overnight parking. Okey Skidmore moved to approve a fee of \$75.00 if parked overnight between the hours of 1 a.m. to 6 a.m. and Gabe Pena approved the motion. Brian Good, Stanley Boyd, Zenda Vance, and Lori Tabit approved the motion. Motion carries 6-0.

Discuss and act on 4 way at Huse Street and E Maple Avenue. It is hard to see with cars parked on side of road and coming up the hill. Chief Kinzer is to do a speed study on Maple Avenue and report back to Council. No action taken. This will be put on the July agenda.

Discuss and act on American Relief Fund possible projects. It's a lot of money for big projects. Stormwater needs to meet EPA. Town Superintendent Matt Dieterich is checking on guidelines especially on Frog Town. Mayor Cruikshank said we need to find out what the money can b used for. Any questions will b sent to Senator Joe Manchin's office. The park could use a splash pad which takes a lot of money. They have \$75,000.00 set aside and the cost could be \$250.000.00. The skate park could be more friendly user and basketball courts need updates. The Town will receive one half now and the other one half next year. Recreation is human infrastructure and flooding is a storm water quality issue. The money has to be spent by 2024. Mayor Cruikshank asked if anyone needed to go into Executive Session. Lori Tabit moved to approve to go into Executive Session to discuss a Personnel Issue. Council went into Executive Session at 7:06 p.m. and reconvened at 7:19 p.m. with no decisions rendered.

Mayor Cruikshank asked for a motion to adjourn the meeting. Zenda Vance moved to approve. Meeting adjourned at 7:20 p.m.
