Discuss and act on recommendation from Planning and Zoning Commission to advertise to a change to the current zoning on Lively Street across from Csssis Dental from R1 to R2 and to then amend our current zoning ordinance to add the definition of Hostel to allowable uses after Public Hearing. Discuss and act on Intersection & Street Review for painting no parking to allow for fire truck turning: Heslep/Reynolds, Heslep/Mahan, East Maple/Hues, Keller/Thomas, Park/Academy, East Maple, Sarah, Lindberg/Short and for other (Grace low hanging limbs and on street parking) (Talbert/West Maple for bushes on each side) (West Maple/Hinkle bushes for visibility) Lori Tabit moved to approve and Stanley Boyd seconds the motion. Okey Skidmore, Zenda Vance, and Gabe Pena approved the motion. Motion carries 5-0.

Discuss and act on American Relief Fund Projects. Council discussed different things to do, Stormwater, Broadband Partnerships, Town Park-Fencing & repair backstop, Janulato Park, upgrade hydrants to name a few.

Discuss and act on Thrasher Engineering for GIS mapping storm water/waste water, not to exceed \$31,000.00. Okey Skidmore moved to approve and Lori Tabit seconded the motion. Zenda Vance, Stanley Boyd, and Gabe Pena approved the motion. Motion carries 5-0.
