Discuss and Act on selecting an Engineering Firm to complete the Stormwater GIS Project. Gabe Pena moved to approve Thrasher Engineering and Loti Tabit seconded the motion. Okey Skidmore, Brian Good, Stanley Boyd, and Zenda Vance approved the motion. Motion carries 6-0.

Discuss and Act on Z-001-21 252 Lively Street, SURF 4.52 PT Bradford 4.52 acres from R-1 to R-2. Okey Skidmore moved to approve and Zenda Vance seconded the motion. Gabe Pena, Stanley Boyd, and Brian Good approved the motion. Motion carries 5-0. Lori Tabit opposed.

Discuss and Act on monetary donation to the Fayette County Emergency Food Assistance Center. They need a metal awing for the outside of the building. Stanley Boyd stepped out of the meeting due to his position on the board. The cost will be \$5425.00. Frances also said they would need 2 heaters so people can keep warm and safe distancing to enable covid safety protocols. The cost would be \$149.00 each. Okey Skidmore moved to approve and Zenda Vance seconded the motion. Lori Tabit, Gabe Pena, and Brian Good approved the motion. Motion carries 5-0. Stanley returned to the meeting after the vote took place.

Discuss and Act on renewing contract with TextmyGov for another year-- \$2,000.00. Zenda Vance moved to approve and Lori Tabit seconded the motion. Brian Good, Gabe Pena, and Stanley Boyd moved to approve. Motion carries 5-0. Okey Skidmore opposed.

Discuss and Act on Chief of Police/Police Department. Zenda Vance made a motion to go into Executive Session and Gabe Pena seconded the motion. Council went into Executive Session at 6:40 p.m. and reconvened at 7:29 p.m. with no decisions rendered.
