## VISITOR'S COMMENTS:

Curtis Paul spoke about the accident on Route 16 involving Teddy Ewing. He would like to see public sidewalks and the speed limit reduced in the area where the accident happened. Local kids walking and riding bikes needs sidewalks in that area. Would like to see speed limit reduced to 25 mph . Mayor Cruikshank said the traffic study needs to be done by DOH. Matt Diederich stated the Town requested sidewalks 2 years ago but DOH denied it.

Stacey Issacs works for Hospice and has seen someone jump off the New River Gorge Bridge and would like to see Suicidal signs on the bridge. She would like them to be on both ends of the bridge. She would like to have the Community Support and will be going to Fayette County Commission for support. Even if it saves one life it will be worth it. Sheriff Fridley is in support of it. Mayor Cruikshank said there is a group and the Town can share a letter in support of it set up by the WV Suicidal and other involved community members.

Craig Eger would like to see a about a grant paying for sidewalks to address safely in mind on Route 16. What can Community do for electric signs in different places for speed. He would like to see the Community and Council work together and get things done and see what can be done to move forward.

Maura Kistler said we are putting heads together to see what can be done for safely. Has confidence in Council. Maybe to do a petition
to DOH to lower speed limit. Brian Good said DOH wouldn't lower the speed limit on Nickelville Road.

Stanley Boyd would like to see if we can do an open form meeting with DOH and send letter to Governor. Go to Charleston if we need to and talk to them.

Gabe Pena would like to look and see how to make area safe. Grants were submitted in January for Community improvement for other projects.

Mary Rahall wanted to know the reason for changing the Street lights to LED. She said kids ride bikes down Maple and has seen them about get hit by cars. Maybe bike lanes would help. Ditch at Pies and Pints needs to be fixed. She is always thinking about safely.

Sarah Edwards of Free Folk Brewery so devasted to hear about the death of Teddy Ewing. She is concerned about the safely of her business with people crossing the road on Route 16. She called DOH in Lewisburg and received an email back saying studies will be done. Safety awareness to be top priority.

Casey Poveloues is new to the area and lives in Oak Hill. He had a Mom who would take him out in the woods and roads to teach him about safely. A lot of kids are missing this. We need a campaign to teach safely and how to walk facing traffic.
