Terry Ritterbush said Lori Tabit should not be able to vote on Food Trucks because it would be a conflict. This was noted, and when the time comes for the Council to vote on Food Trucks, Lori Tabit will not be part of the discussion.

Lewis Rhinehart wanted to know if Food Trucks needed permits. Carl Harris assured him they do need to be permitted as any business in Fayetteville.
