Present were Mayor Sharon Cruikshank, Recorder Zenda Vance, Council Members Stanley Boyd, Okey Skidmore, Brian Good, Lori Tabit, and Gabe Peña. FINANIAL

Discuss and act taking the roadway with Riley, Shingledecker, New River Health and Conrad as a Town Street-Callahan Edwards Lane. Brian Good moved to take the Street and name it later and Stanley Boyd seconded the motion. Gabe Peña, Zenda Vance, Lori Tabit, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on increasing coverage for fire department uninsured and underinsured. Zenda Vance moved to approve, and Lori Tabit seconded the motion. Brian Good, Gabe Peña, Stanley Boyd, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on naming of Streets in Town Park first roadway- Veterans Way. Zenda Vance moved to approve, and Stanley Boyd seconded the motion. Brian Good, Gabe Peña, Lori Tabit, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on naming of Streets in Town Park second roadway-Pirate Lane. Lori Tabit moved to approve, and Stanley Boyd seconded the motion. Brian Good, Gabe Peña, Zenda Vance, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on street closures by Town Council. Zenda Vance moved to approve and Brian Good seconded the motion. Gabe Peña, Stanley Boyd, Lori Tabit, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on parade permits by Chief of Police. Zenda Vance moved to approve, and Lori Tabit seconded the motion. Brian Good, Gabe Peña, Stanley Boyd, and Okey Skidmore approved the motion. Motion carries 6-0.

Zenda Vance moved to go into Executive Session for a legal issue. The council went into Executive Session at 6:21 p.m. and reconvened at 6:32p.m. with no decisions rendered.

Stanley Boyd moved to adjourn the meeting and Gabe Peña seconded the motion.
