**Discuss Park Board Employees. Okey will be over the employee. No action taken.**

**Discuss and act on request Adam Stephens Dickinson Street Parking lot. Adam is wanting an address for the Wood Iron so people will be able to find it. The parking lot is private property, and he would like to name it Henry Street. John Vernon said it would have to be approved 2**

**through Council and would need to ask 911. Mayor Cruikshank said she would put it on next month's agenda.**

**Discuss and act on Gil Willis's request on opening right of way for Autumn Lane and Craig Avenue. Mr. Willis would like to have Council act and open up Autumn Lane. **Discuss and act on Fayetteville CVB request for street closure and stage usage for 2023 Bridge Day Chili Cook Off – Tabitha Stover. Gabe Peña moved to approve closing the street and usage of stage and Lori Tabit approved the motion. Stanley Boyd, Zenda Vance, and Okey Skidmore approved the motion. Motion carries 5-0.**

**Discuss and act on opening bids to repair Keller Avenue wall. One bid was received from Bastion Group for \$250,000, \$50,000 contingency for unknown conditions. This project can be done between June 26th through August 24<sup>th</sup>. Must be completed on time and the road closure must be approved by the State DOH. Okey Skidmore moved to approve, and Lori Tabit seconded the motion. Gabe Peña, Stanley Boyd, and Zenda Vance moved to approve. Motion carries 5-0.**

**Discuss and act closing ARPA bank account. Zenda Vance moved to approve, and Gabe Peña seconded the motion. Stanley Boyd, Lori Tabit, and Stanley Boyd approved the motion. Motion carries 5-0.**

**Discuss and act Guardian Dental, Vision, Life/AD&D and Dependent Life group renewal. Gabe Peña moved to approve, and Lori Tabit seconded the motion. Stanley Boyd, Zenda Vance, and Okey Skidmore approved the motion. Motion carries 5-0.**

**Zenda Vance moved to go into Executive Session for legal issue. The council went into Executive Session at 6:50 p.m. and reconvened at 6:56 p.m. with no decisions rendered.**
