General Comments and Reminders

Community Clean up on the second Saturday of each month. Supplies are available at Town Hall.

Steve Runyon from DOH was asked about a foot bridge but Matt did not receive a response. AEP is working on right of ways to replace the overhead bridge.

Council/Board Comments

Gabe Peña said they are working on Storm Water. There are 5 different locations. The cost could be 1.4 million.

Okey Skidmore had no new comments.

Lori Tabit said Bridge Day is coming up and looks like it will be a good turnout.

Zenda Vance said Veterans Day Parade is November 11th at 11AM. Come out and bring a Veteran and ride them in the Parade and show them how much we appreciate the price they paid for our freedom.

Department Reports

Fire Department: John Vernon said they are preparing for Bridge Day. Members have been in training. Town had requested Unit 33 be sold to Town. He requests if they decide to sell it in the future that the funds would go back to the Fire Department.

Police Department

Chief of Police Glenn Chapman said they had 206 incidents for the month. The Police department was in the Homecoming Parade and Ansted Parade. The Police Officers are halfway through the academy. The officers are preparing for Bridge Day. Justice Lane will be paved this year.

Visitor's Comments

Brian and Kathy Washington want to see the 2nd Avenue Bridge build back either as a pedestrian or auto. They have a petition with 30 people interested in the bridge and will have more names later. There is a lot of speeding in the area and crossing Rt. 16 is dangerous. There are some who wouldn't mind if it was a foot bridge.

Discuss and act on disposing of 1999 Ford F350 Super Duty Rescue truck per state requirement. The Street Department wants the truck. An agreement will be made and if sold the money will go back to the Fire Department. Gabe Peña moved to approve, and Lori Tabit seconded the motion. Brian Good, Stanely Boyd, Zenda Vance, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on contracting with AlignHR for HR Assessment. The cost will be \$1,900 and they should have it completed in 3 to 5 weeks. Stanley Boyd moved to approve, and Gabe Peña seconded the motion. Brian Good, Zenda Vance, Lori Tabit, and Okey Skidmore approve the motion. Motion carries 6-0.

Discuss and act on approving job description for new clerk. Gabe Peña moved to approve and Lori Tabit seconded the motion. Brian Good, Stanley Boyd, Zenda Vance, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on promotion Cindy Kennedy to Patrolman 1st Class Zenda Vance moved to approve, and Stanley Boyd seconded the motion. Brian Good, Gabe Peña, Lori Tabit, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on promotion Charles Johnson to Corporal. Stanley Boyd moved to approve, and Gabe Peña seconded the motion. Brain Good, Zenda Vance, Lori Tabit, and Okey Skidmore approved the motion. Motion carries 6-0.

Discuss and act on \$25 monthly cell phone reimbursement. Kathy informed Chief Glenn Chapman that taxes will have to be taken out of the check according to IRS. Glenn said he wanted to discuss it with officers. Tabled no action taken.

Chief Glenn Chapman asks to go into Executive Session to discuss Personnel Issue. Zenda Vance moved to go into Executive Session. The council went into Executive Session at 7:04 pm and reconvened at 7:25 pm with no decision rendered.
