Mayor Sharon Cruikshank called the meeting to order.

The Pledge of Allegiance was led by Mayor Cruikshank.

Presentation on ICE Collaborative and Youth Prevention with Katie Johnson. This is done for Fayetteville PK* 7th and 8th grade Student data. This is a survey in different groups for Risk and Protective Factors: Community and Peers, Protective Factors: Peers, Risk and Protective Factors: Family, Leisure Time, and School. Youth who participate in organized activities that are led by an adult are 3x less likely to use drugs and alcohol. Kids who are out after midnight are 3x more likely to use substances. Students who say school is helping them achieve their goals are 2x less likely to use substances. Ice Collaborative works with WVU for youth prevention. They would like to see the Town get involved on projects or events to help.

Discuss and act on hiring of Full Time Town Hall Clerk at \$13.65. Matt said they received 9 applicants and 3 of 4 selected were interviewed. One of the 4 selected did not show up for their appointment. He asked for the Council to approve the hiring of Ronda Falk. Gabe Peña moved to approve and Zenda Vance seconded the motion. Brian Good, Stanley Boyd, Lori Tabit, and Okey Skidmore approved the motion. Motion carries 6-0. After 6 months probationary period there would be a .50 raise if all goals are met.
