License Tax for Partial Year

“Each License issued prior to the first day of January of any year shall be charged for the full rate and each license issued on or after the first day of January shall be charge for one half the full rate.”

Should check be given of any license fees, and returned for lack of funds, license shall be revoked as provided by law. Penalty of \$50 per month for continuing to do business without a license (Chapter 2 Article 751.99)
