

Fayetteville Town Council met in Regular Session on December 19, 2024, at 6:00 p.m. at Town Hall.

Present were Mayor Sharon Cruikshank, Recorder Zenda Vance, Council Members Stanley Boyd, Okey Skidmore, Lori Tabit, Brian Good, and Gabe Peña. Also present were Town Attorney Carl Harris, and Town Manager Matt Diederich. Kathy Williams was not present.

Prayer was offered by Sharon Cruikshank.

Mayor Sharon Cruikshank called the meeting to order.

The Pledge of Allegiance was led by Sharon Cruikshank.

Financial

Review and approval of mid-month invoices. Zenda Vance moved to approve and Lori Tabit seconded the motion. Motion carries 6-0.

Unfinished Business

Discuss and act on Budget Revision. Zenda Vance moved to approve and Lori Tabit seconded the motion. Motion carries 6-0.

New Business

Discuss and act on request by FCVB for the Wizard Weekend to utilize town hall, Court Street road closure and Roy Mooses presentation for Saturday, January 25th. Brian Good moved to approve and Gabe Peña seconded. Motion carried 6-0.

Discuss and act on Court Street closure, in front of the Court House, request by Bryant Baker on February 15, 2025, from 7 a.m. - 9:30 a.m. for the Cabin Fever Race. Brian Good moved to approve and Lori Tabit seconded the motion. Motion carries 6-0.

Discuss and act on renewal of Text MyGov notification for \$2,000. As of now, 244 people signed up for it. We need to promote it to get more

people to sign up. Brian Good moved to approve and Gabe Peña seconded the motion. Motion carries 5-1. Okey Skidmore voted against.

Discuss and act on Police Department Personnel-Police Chief position. Glenn Chapman resigned as of December 13, 2024. Brian Good moved to go into Executive Session to discuss a Personnel Issue and Gabe Peña seconded the motion. The council went into the Executive Session at 6:11 p.m. and reconvened at 7:48 p.m. with no decisions rendered.

The council went back to question 5 on the agenda. Okey Skidmore moved to hire Tyler “Ty” Hogan as the new Chief of Police with a 6-month probationary period and Brian Good seconded the motion. Motion carries 6-0. Starting salary will be \$72,480 and will be revisited after the probationary period. Will be reevaluated in 6 months. The council also approved, making her salary for the back pay as of October 16, 2024.

Zenda Vance moved to adjourn the meeting. Meeting adjourned at 7:55 p.m.
